**ENTRY DEADLINE:**      **Wednesday, January 20, 2010**

- Location:** Okotoks Recreation Centre,  
99 Okotoks Drive, Okotoks (corner of Milligan Dr & Okotoks Dr)
- Facility:** 25 metre, 6 lane pool, semi-electronic timing.  
Timed Finals, single ended meet.  
4 lane, 25 meter Warm up/Warm down pool available throughout the meet.
- Eligibility:** This is an Open invitational meet.
- All swimmers must be registered with SNC.
  - Swimmers are expected to be at or near (<5%) the 2008-10 Alberta Trials Time Standards or higher in their respective age group for entry.
- Age Groups:** 10 & Under, 11- 12, 13- 14, 15 & Over  
Session 1 and 3 - 12 & Under  
Session 2 and 4 - 13 & Over
- Rules:** All SNC rules will apply.
- Scratch deadline will be 30 minutes prior to the commencement of the session.
- Meet Format:** This is a short course competition.
- All events will be timed finals.
- Relays
- Relays are all timed finals with no limit on the number of teams.
  - Relays will be swum at the end of the session.
- All events will be senior seeded. Events will run slowest to fastest.
- Entry Fees:** Individual:      \$6.75 per event;  
Relays:                \$7.25 for relays;  
Time Trials:        \$6.75 per event.  
Deck Entries:      \$12.00 per event,

Please make cheques payable to **Foothills Stingrays Swim Club (FSSC)** and should be submitted with entries prior to meet.

- Entries:** Entries limited to the first 275 swimmers. Please call or email ASAP with your intention to attend.
- Swimmers are limited to a **maximum of seven (7)** individual swims (4 per day) plus relays.
  - Entries should be sent in a Hy-Tek file via the Swim Canada website.
  - Entry fees for clubs with more than 20 swimmers not entering swimmers on Hy-Tek will be \$8.00 per swim.
  - Time trials will be available between sessions, time permitting.
- Entry Times:** Entry times are **required** for all entries to facilitate timing of the meet by the meet manager as well as a dequalifying check. NT entries will not be accepted.
- Deck Entries:** Deck entries will be permitted under the following circumstances:
- **All deck entries will be \$12.00 to be paid at time of request.**
  - Will be permitted provided an extra heat is not created.
  - All Deck entries are exhibition swims and will not be scored.
- Time Trials:** Time trials will be offered between sessions at a cost of **\$8.00** per swim.
- Swimmers are limited to 2 time trials per session subject to time availability.
  - Clubs will be required to provide timers.
  - Time trials will be offered for the 400 IM and 1500 Free (time permitting).
  - Registration deadline will be approximately 1 ½ hours prior to end of session.
  - Time trials must be paid for at time of entry.
- Scratches:** Scratches should be received by 6 PM, Friday, January 29<sup>th</sup>, 2010 to avoid being charged the Meet Entry Fee. On the day of the meet, a scratch sheet completed with **name of club, the name of the swimmer and the event numbers** must be handed to the Clerk of Course no later than 30 minutes before the start of the meet.
- Billeting:** There will be no billeting offered at this meet.
- Officials:** Visiting Clubs will be asked to provide volunteer officials. An officials' Volunteer form is enclosed for your use. Please include this form with your entries and indicate the names and contacts of your Club officials and/or Officials chairperson.
- Hospitality:** Food and beverages will be available for all working officials and coaches.
- Scoring & Awards:** Events are open. Individual events will be scored in the above mentioned age groups. Points awarded are 1<sup>st</sup> to 6<sup>th</sup> place - 7,5,4,3,2,1. Medals will be awarded for 1<sup>st</sup> to 3<sup>rd</sup> place with ribbons to 6<sup>th</sup> place in each individual event. Relays will be scored double and points awarded for 1<sup>st</sup> to 6<sup>th</sup> place by age group. Relay ribbons will be awarded to the top three teams for each gender in the session. There will be a team aggregate plaque awarded to the top scoring team in each of the two ages group sessions (12&Under, 13&Over).

**Changes or**

**Event Cancellation:** Meet Management reserves the right to alter, revise, limit enrollment, or otherwise modify the meet program to allow for maximum swims in the time allotted. Every effort will be made to ensure that all entry swims are completed. Teams will be advised of any changes as they occur.

**Information for****Coaches:**

There will be no formal coaches meeting. Information for coaches will be included in coaches' envelopes along with heat sheets, relay cards and scratch/deck entry forms. These envelopes can be picked up at the meet office shortly before the commencement of warm ups on Saturday, February 6<sup>th</sup>. Scratches should be entered on the forms supplied and delivered to the Clerk of Course at least 20 minutes before competition is scheduled to start each day. Deck entries and/or time trials entries should be submitted to the clerk of course with fees.

**Entry Deadline:**

Completed entries and cheques (payable to Foothills Stingrays Swim Club - FSSC) are due by **Wednesday January 20th, 2010**. A complete entry package will include:

- Hy-Tek entries.
- Entry report from Hy-Tek
- Entry fees (cheque or money order)

**NOTE:** E-mail of Hytek entries will be accepted as initial acceptance in the meet, however, the hard copy and entry fees must be received to hold your place.
